You are receiving this letter in compliance with the School Pesticide Notification Law, which mandates all faculty, staff and persons in parental relation that have requested to be notified, must be provided with a written summary of pesticide applications four times each school year at the following intervals: within 2 days of the beginning of the school year, within 2 days of the end of winter recess, within 2 days of the end of spring recess and within 10 days of the end of the school year.
