The impact of equalization rates on all four towns

Equalization rates will affect taxes in 2022

What are equalization rates?

- A town's assessor assigns a value for each property. This is called the "assessed" value and is based on a formula established by NYS Office of Real Property Services (NYSORPS).
- Assessors update these values periodically to reflect the most current market value.
- New York State compares market data to assessed values by reviewing property sales in each municipality. Based on market trends, NYS then assigns a "corrective figure" an equalization rate, to better reflect actual market values.
- The purpose of this process is to ensure that all properties in the state are taxed in an equitable manner, within such numerous taxing jurisdictions.

Federal Stimulus UPDATE

In 2020 and 2021, Congress passed three stimulus bills that provided funding to address the operational and instructional impact of COVID-19 on schools. Districts must allocate these funds for specific services and programs over a three-to-four-year span.

Federal stimulus is restricted and separate from revenues that support the general expenditure plan. Both federal and state government entities caution school districts to be mindful in their planning for and prioritizing these stimulus-related expenses, as this funding will end in three-to-four years. After 2024, districts will be responsible for sustaining the costs for any programs, projects or initiatives.

The following table contains updated information on the three stimulus packages, the amount Spencerport will receive, and the funding end date.

On March 8, updates were presented to the Board of Education detailing the three federal stimulus plans. Specifically an update was provided on the American Rescue Plan (ARP) Act allocations, which is separated into the **Elementary and Secondary School Emergency Relief (ESSER-90%) funds**. A breakdown of how these funds were allocated may be found below:

- 4 Multi-Tiered System of Support (MTSS) Teachers on Special Assignment (TOSA)
- 1 K-8 Special Education TOSA
- 9 Content Focus Coaches (CFC)
- K-5 School Counselor
- Summer help for facilities and technology
- CFC Mentors
- Contract with Rochester Regional Health for mental health services
- Professional Development
- Pre-K and K-12 classroom furniture, including instructional technology

For districts that received the additional state reserve allocation (from the ARP Act), those funds must be used to address the academic impact of lost instructional time, evidence-based comprehensive after-school programs and summer programs.

Equalization rates in Spencerport

A property's assessment should be at 100% of its market value (the price for which you could sell your property). The state calculates the equalization rate for a given municipality, and the towns of Ogden, Greece, Parma and Gates have reported the following equalization rates for 2022:

• Ogden: 82%

• Gates: 91%

• Greece: 86%

• Parma: 81%

Example for Ogden:

An equalization rate of 0.82 means that a property is assessed at 82% of its full market value.

Full value = assessed value/equalization rate

Full Value = \$82,000/0.82

Full Value = \$100,000

School districts do NOT control assessments or equalization rates. School districts only control the tax levy, or the amount that taxpayers within its boundaries must contribute to the district's budget.

Because of this, the tax rate for the towns fluctuate. Below are examples of tax bills for homeowners based on the budget development estimates in March, and the percentage changes due to the equalization rates.

An estimated school tax bill based on an average home valued at \$200,000:

We will provide the projected tax rates and school tax bills for each town in the budget edition of Cornerstone prior to the vote on Tuesday, May 17.

The Board of Education sets the actual tax rate is established in the summer.

Deadline to run for school board is Apr. 18

Candidates interested in running for the Spencerport Board of Education are asked to contact Marcy Clapper, the Spencerport Board Clerk, to obtain a packet of information, which includes all the petition requirements, deadlines, and profile material for Cornerstone.

Board of Education candidates must submit their petitions, signed by at least 31 qualified school voters of the district, by Mon., April 18 at 4 p.m. This number is calculated based on education law which states that petitions shall be signed by at

least (25) qualified school voters of the district or 2 percent of the number of voters who voted in the previous election (1,572), whichever is greater. Therefore, 31 signatures are required.

The Board of Education will have two seats up for election this year. The three-year terms, currently held by Greg Kincaid and Gary Bracken, will begin on July 1, 2022, and end on June 30, 2025.

The primary duties of the board are to develop the broader, long-range goals and policies which determine the basic framework for the educational programs, services and facilities to be offered to the youth of the community.

Munn Elementary Teacher named New York

State Master Teacher



Munn Elementary School fifth-grade teacher Matt Fink has been selected as a New York State Master Teacher and will join the Finger Lakes cohort based at SUNY Geneseo. Master Teachers

are dedicated K-12 professionals in the STEM (Science, Technology, Engineering, Mathematics) fields. This year's Master Teachers include 55 elementary school teachers. The selection process includes

an extensive application, tests, and interviews. Governor Kathy Hochul announced the 230 new statewide Master Teachers on February 4.

As a Master Teacher, Fink will have access to specific STEM-related professional development opportunities sponsored by New York State. "My responsibility is to learn new, cool STEM activities, concepts, and philosophies to bring back to the classroom and school," said Fink. "The things that I will be learning should permeate through all the content areas so instead of teaching separate subjects, we will be able to

integrate science, technology, and math within other areas of study."

"Thank you to New York State for providing this opportunity," said Fink. "To be able to get this training and bring it back to the school district is going to be valuable to the students and other teachers."

Fink joins previously selected Master Teachers from Spencerport, including Matt Amoroso, Nancy Mancuso, Steve Schultz, and Bryan Swanson.

Illness and COVID-19 Exposure

New York State Department of Health Guidance

ON ISOLATION, QUARANTINE OR IF SYMPTOMATIC

Those who are exposed or test positive are encouraged to immediately follow these recommendations. No one from the Monroe County Department of Health or district Human Resources Department will personally connect with you.

Quarantine

Exposed and NO quarantine

- Anyone up to date on COVID vaccinations
- 12 and older who have received all vaccinations, including booster
- 5-11 who have completed primary series of vaccinations
- Anyone who has confirmed COVID within the last 90 days (tested positive using antigen or PCR test)

Exposed and unvaccinated

Change for schools (K-12): students and staff previously required to quarantine if unvaccinated may now attend school or school-based activities if they undergo recommended testing.

NOTIFICATIONS

Notifications of COVID cases will be reported in the same format as our previous weekly update; however a school-specific list will now be included in each principal's family messages.

It is important to note that we can and will conduct individualized contact tracing when we are aware of exposures to immunocompromised individuals, but the general notification will come in the form of weekly cases by school building.

Isolation

Tested positive

- Notify your school nurse or supervisor.
- Register a positive home test with Monroe County here.
- Any student or staff member who tests positive for COVID-19 must stay home and isolate for 5 days.
- They may return to school on days 6-10 with the use of a wellfitted mask. If a student or staff member is unable to tolerate a mask on days 6-10, they must remain home for the full 10 days of isolation.
- NYSDOH recommends that anyone exposed to COVID-19 should test immediately after known exposure and again on day 5.
- School nurses can help facilitate this testing if necessary or an athome rapid antigen test can be used
- Masking, regardless of vaccination status, is strongly recommended for 10 days after a known exposure.

OPTIONAL MASKING

Masks remain optional. You are welcome with or without a mask, and please respect that others have the same choice.

Symptomatic

If a student or staff member starts to exhibit COVID-19 symptoms:

please stay home, and administer an at-home rapid COVID test.

We are now able to accept results from at-home rapid antigen tests for symptomatic individuals.

Tested Positive

If the result is positive, please refer to the action steps under the isolation column.

Tested Negative

If the result is negative, the person is fever free for 24 hours, and their symptoms are improving, then they may return to work or school.

Symptoms at school

Any students who exhibit symptoms during the school day should visit the school nurse.

- All students who enter the health office will be offered a mask.
- The school nurse will assess symptomatic students and may offer a rapid COVID-19 test with parental consent.

Parental consent will consist of a written affirmation via email to the school nurse.
