You are receiving this letter in compliance with the School Pesticide Notification Law, which mandates all faculty, staff and persons in parental relation that have requested to be notified, must be provided with a written summary of pesticide applications four times each school year at the following intervals: within 10 days of the end of the school year, within 2 days of the end of winter recess, within 2 days of the end of spring recess, and within 2 days of the beginning of the school year.

The Spencerport Central School District is required to maintain a list of persons in parental relation who wish to receive 48-hour prior written notification of certain pesticide applications. **** If you know of anyone that is interested in being added to the notification list, please have them contact the Spencerport Facilities Office at 349-5194.**
