Capital Project Goal Discussion


1. Our goal as a district is to create an educational environment that will help all our students grow through enhancing our facilities.

2. We recognize that over the years the needs for the use of our facilities and for education have changed greatly, and we seek to meet these needs through our proposed capital improvement project.

Capital Project Priorities

- Desire is to balance operations, infrastructure, and programmatic scope
- Many programmatic items will become candidates for a long range plan and subsequent capital improvements
- Operations related items may have big ticket prices and low pizzazz levels



Capital Project Priorities

- Operational Scope Framework
 - Health & Safety
 - Accessibility
 - Code Compliance
 - Life Expectancy
 - Energy Utilization & Efficiency
 - System Functionality
- Big ticket items.....



Operational Needs Roofing

- Numerous roof sections coming to end of warranty periods
- Value: Just over \$17 million



HVAC Equipment

 Boilers: Majority replaced in 2003 and are nearing end of useful life

• Air Handlers: Many units dating back to 1970s which are

past their useful life

Value: At least \$15 million



Roadways and Parking

- Progress was made through past projects, but we still have areas that need work.
- Value: At least \$14 million



Operational Needs Fire Alarms

 Operational but main control panels are aging out. Parts are difficult to obtain to repair breakages.

• Value: At least \$2.5 million



Secure Entrances

Modernized entrances with security updates at all buildings

- Vestibule type entrances
- Value: Roughly \$7 million



- Operations and Infrastructure
 - Roofing
 - HVAC Equipment
 - Roadways and Parking
 - Fire Alarms
 - Secure Entrances

Roofing	\$17 million
HVAC	\$15 million
Roadways	\$14 million
Fire Alarms	\$2.5 million
Secure Entrances	\$7 million
Total	\$55.5 million

Available Project Funding: \$18,850,000 million Available Construction funds: \$13,693,964 million
