The Business Session of the Board of Education of the Spencerport Central School District was called to order at 7:03 p.m. E.D.S.T. by the Vice President, Ms. Gillette, in the Board of Education Conference Room in the Administration Building.

## 3. BOARD RECOGNITION

Fall Athletes - Ms. Gillette and Mr. Milgate congratulated the fall sports teams on their accomplishments. Mr. Pelin, the Director of Athletics, commended the fall teams on their outstanding performances and their ability to "follow through" per this year's athletic department theme. He

introduced Mr. Austin, the Boys Volleyball Coach for the past 11 years with a career record of 132-104, the most wins in District history. The team finished as Monroe County Division II and Section V Class B Champions. Mr. Austin introduced each athlete on the team and provided some recognition on their accomplishments and those that received all county recognitions. The team displayed grit and resiliency as they had previously lost to Brighton and were able to defeat them at the Section V Championship. Mr. Austin was named the MCPSAC Division II and Section V Class B Coach of the Year.

Mr. Pelin introduced Mr. Mueller, assistant coach of the Girls Soccer team. Mr. Schneider was not able to make it as he and a few of the athletes were attending the Section V Girls Soccer awards banquet. He has coached for 15 years and has a career record of 145-106-24. The team finished as Monroe County Division II, Section V Class A and Western Regionals and NYSPHSAA Class A State Champions; ranked #1 in NYS and ranked #5 in the nation. Mr. Mueller spoke about the outstanding students on the team, who are great role models, and are phenomenal on and off the field. The team handled pressure really well and met every challenge, having never trailed in a game until the State finals, and scoring to tie the game in overtime. Mr. Schneider was named MCPSAC Division II and Section V Coach of the Year and has been nominated for the NYS and National Coach of the Year. Multiple plaques and banners were presented to both teams. Ms. Gillette congratulated the teams and commented on how many records had been broken this season. Mr. Kincaid congratulated the teams on back to back titles. Ms. Czarnecki had a fun experience with younger students eagerly watching the girls' soccer game in Buffalo on tv and thanked the students for their good sportsmanship as many younger students look up to them. Mr. Pelin spoke about the academic achievements of the fall teams, participation numbers, sportsmanship awards, community service projects performed and school spirit highlights of Homecoming and hosting "Friday Morning Lights" and thanked the Board for their continued support.

## 6. **BOARD OF EDUCATION**

## 6.1 President's Report and Communication

Ms. Gillette commented that Mr. Drake provided a fantastic review of the facilities buildings and that they are in great shape.

## 6.2 Board of Education Members' Reports

Ms. Czarnecki also reviewed the Cosgrove building and commented that Mr. Drake did a great job being informative of needs and concerns. Mr. Kincaid toured the Taylor building and spoke about the great progress in the work that's being done. He said that the parking lot and bathrooms look great. He attended the great production of All Shook Up at the high school and the Business Honor Society induction. Mr. Miceli complimented Mr. Wood on the great job being done with the 1:1 initiative and the facilities task force meetings.

## 7. SUPERINTENDENT'S REPORT

## 7.1 Special Education Report

Mr. Zinkiewich introduced Ms. Richmond, the Director of Special Education. She provided the board members with a video walk-through of special education classes. The Munn School now houses a special education preschool program in conjunction with BOCES 2. Six students with a disability are grouped with six general education students. It is a fun and enriching classroom. The TEACCH based approach that's being utilized in the 6:1:1 class at Canal View for students with autism was discussed. It's the idea of structured teaching; physical, scheduling and teaching methods. It's a behavior based program to maximize independence. Ms. Richmond spoke about the continuum of services available in all our buildings; 6:1:1, 8:1:1, 12:1:1, 15:1, integrated coteaching classes as well as inclusion initiatives. The high school has a new transition program for 18-21 year old students that require continued education. They work on adaptive, self-help, and work based skills. The classroom is set up like a home, where students can learn household skills, how to cook and manage day to day life. They spend the second half of their day out in the community for work based learning. Ms. Richmond highlighted the BOCES 2 Project Search program, where students in their last year receive soft skills training in an internship at Strong Hospital. Previous graduates of the program have been hired full time and we receive many

compliments on our students attending the program. She mentioned the process of possibly developing a Project Search program in Spencerport with local businesses. Ms. Gillette asked what needs to be done in order to start the program, and many factors would need to be reviewed. Ms. Richmond indicated that they are still working on CDOS options for 9<sup>th</sup> and 10<sup>th</sup> graders and increasing inclusion for 15:1 students. Discussion ensued about the increasing number of younger students requiring an increased level of support and Mr. Kincaid inquired as to what the County is saying to give the students what they need. Ms. Richmond replied that there is a crisis countywide and that more space, qualified teachers and aide candidates are all in short supply.

# 7.2 Facilities Task Force Update/Discussion

## 7.3 Comptroller Corrective Action Plan Update

Mr. Milgate introduced Mr. Wood who reported on the Comptroller Corrective Action Plan; the report which was given to us approximately a year ago. The first item deals with realistic appropriations. Our process is very thorough in communicating with the Board and the community. We will be looking at trends in accounting codes. The second item requires the district to review reserves annually. The district provides a written plan of reserves at its April presentation. We will work on a plan to prepare a policy or procedure regarding this. The third item focused on the intent to replenish reserves be included in the budget. This is something that we have never done. We have reservations and are concerned about putting money in reserves that may then become a surplus. If the district then uses the surplus to help with the tax levy, the Comptroller then penalizes a district. Regarding the fourth item, the Board has already put two policies into effect regarding reserves.

## 7.4 Second Reading of School Lunch Policy

Mr. Saltzberg gave a second reading of the School Lunch policy. A few changes were made pursuant to questions raised by Mr. Hutton. His recommendation was to adopt the policy. Mr. Miceli asked if the policy would impact the budget, and Mr. Saltzberg replied that the policy is to address the process. The USDA and NYSED have mandated that school districts adopt a policy with a grace period.

A motion was made by Mr. Kincaid and seconded by Mr. Miceli to adopt the School Lunch policy.

#### 7.5 Financial Report

Mr. Wood presented the financial report for the period ending October, 2017. The major revenue at this time are taxes. The State Aid Output report is still not available; once available a more detailed analysis will be provided. We have been looking at trends, evaluating and analyzing expenditures. Nothing appears to be out of the ordinary. We will be looking more closely at 2017-2018 expenses as we develop the 2018-2019 budget.

The School Lunch contractual budget is much higher due to an increase in equipment repairs. This continues to be a concern and at year end the district may make a recommendation to increase the allocation for school lunch to help address these issues. We are hoping that the relaxed federal guidelines will increase revenues. A question was raised about perhaps including the repairs as part of a future capital improvement project and the question of state aid was mentioned as the school lunch fund is an independent fund.
